Academic calendar

The academic year 2017/2018 begins on first November 2017 and ends on 31 October 2018.

Admission to First and Second Level Academic Diploma Courses

- 1) Foreign students who are citizen of a State of the European Union, send in the applications following the same rules of Italian students.
- 2) Foreign students who aren't citizen of the European Union and aren't resident in Italy have to send in documents at the Italian Embassy of their country.
- 3) Foreign students who aren't citizen of the European Union but are resident in Italy send in the applications following the same rules of European Union students.

The admittance to First Level and Second Level Courses of Niccolò Paganini of Genoa is restricted and possible only by exam.

It won't be necessary to send paper documents, because the Conservatory receives per e-mail a recording of the application.

1 April – 31 May 2017	Candidates have to send in applications.
before 30 June 2017	The calendar of entrance examinations is published.
2-9 September 2017	Entrance examinations
before 19 September 2017	The Conservatory publish the pass-list of fit candidates and, basing on available positions, of admitted candidates.

Admission programme to First and Second Level Diploma Courses is divided in the following tests:

- a) According to a special agreement, foreign students equalized to University students, have to pass a written test (divided in three parts) to verify their knowledge of the Italian language at B2 level. Dates and place of this test are written on the Conservatory's institutional website www.conspaganini.it. Tests modes and required scores are
- b) written -in Italian, English and Chinese language- on the Italian Language and Culture School's website (Scuola di lingua e cultura italiana: <http://www.studenti.unige.it/areaint/scuoladilinguaitaliana/>).

To know better test's subjects, students may visit on the same website the "Sillabo" created for them.

Students have to do the test if they haven't the required certification. Who doesn't pass the test may not do the practical exam. Who passes it but has not a sufficient knowledge of the Italian language, has to attend an Italian course. This course's number of hours is decided basing on verified competences.

- c) Evaluation test of student's musical general competences;
- d) Practical exam related to the **school (course)** required by the student.

The titles will be valued before the examination to verify competences' level and decide if they have to do the test or not.

Workshops

Every year, the Conservatory offers several workshops (see the list on www.conspaganini.it). These workshops are free for students regularly registered to the Conservatory and are opened to external students if there are available positions. They have to pass a test (prepared by the Teacher with the Principal's opinion) and pay a tax. External students may take part in the didactic activity of the workshop and artistic activities connected to it.

To the Conservatory's students will be recognized credits related to the duration of the workshop, according to standards decided by the Academy's Council.

It is not necessary to pay registration/matriculation taxes (*Agenzia delle Entrate*). It is not necessary to pay the Regional Tax for the Right to University Study. It is not allowed to take part in scholarships competitions of the Conservatory.

Masterclasses

Every year the Conservatory organizes Masterclasses with national and international personalities. Registration for masterclasses is free for Conservatory's students and sometimes is allowed to external people (in this case payment modes are every time made known)

Matriculation

Students admitted to Academic Courses of First and Second level have to matriculate before provided dates (or they lose their right to matriculate).

Application have to be sent in (complete of provided enclosures and before provided dates), using the section **SEGRETERIA ONLINE** of the institutional Conservatory's website www.conspaganini.it, following instructions and enclosing digital copies of payment certificates and other required documents. It won't be necessary to send in paper documents because the Conservatory will receive per mail the application's recording.

19 – 24 September 2017	Matriculation of admitted students
from 25 September 2017	Check of pass-lists for the matriculation of other possible fit candidates if there are still available positions.
19 – 23 September 2017	Presentation of individual Plans of Studies. On the Institute's website will be published a calendar of days and hours (from 5 to 9 September) when tutors of every school will be available for students to prepare in the right way the Plan of Studies.
before 3 October 2017	Evaluation of individual Plan of Studies.
before 10 October 2017	Before this date, students may change their Plans of Studies.

Fees - a.a. 2017-2018

In case of students who aren't citizen of the European Union and aren't resident in Italy, the family's ISEE calculation isn't possible. They have to register at the Italian embassy of their country and pay the following taxes:
